I hereby acknowledge and confirm that I have freely, knowingly and voluntarily accepted all risk of injury, illness, disease and medical conditions that I may suffer or incur during the 2020-21 academic year, with full knowledge that I will not be covered or insured by the Emergency Health Insurance Plan provided through NSCC during such term.
